WHEREAS, Employes in the Inspection, Investigation and Safety (G4) and the Clerical, Administrative and Fiscal (A1) collective bargaining units were granted a general pay increase effective July 1, 1972, and August 18, 1972, respectively; and

WHEREAS, An employe who transfers from an employe unit in which the Federal Pay Board approved general pay increase has not been granted shall receive the pay increase on the effective date of the employe's transfer to an employe unit in which the Federal Pay Board approved general pay increase has been granted; and

WHEREAS, The Nisi Order of Certification issued on January 4, 1972, certifying the Inspection, Investigation and Safety unit (G4) was amended by Order of the Pennsylvania Labor Relations Board on September 29, 1972 to include classes 0998 District Lottery Manager and 2312 Veterans' Training Specialist; and

WHEREAS, The Nisi Order of Certification issued on June 2, 1972, certifying the Clerical, Administrative and Fiscal unit (Al) was amended by Order of the Pennsylvania Labor Relations Board on October 6, 1972 to include class 4762 Correctional Records Specialist II; therefore, be it

RESOLVED, That in accordance with Section 709(a) of the Administrative Code of April 9, 1929, as amended, the action of this Board taken July 13, 1956; approving the Compensation Plan for the Pay range adjustments shown on Amendment 282 which is attached hereto and made part of this resolution; and be it further

RESOLVED, That a pay increase of one pay step, or approximately 5% is hereby authorized for all employes in classes 0998 District Lottery Manager and 2312 Veterans' Training Specialist effective September 29, 1972, and in class 4762 Correctional Records Specialist II effective October 6, 1972, except as provided below; and be it further

RESOLVED, That an employe whose present pay rate exceeds the maximum step of the present and proposed pay rate of his class as prescribed in the Commonwealth's Compensation Plan shall receive a pay increase of 1/2 pay step, approximately 2 1/2%, or a pay increase which will raise his pay rate to one pay step, approximately 5%, above the new maximum, whichever is greater; and be it further

RESOLVED, That an employe on educational leave or leave without pay shall receive the general pay increase upon return to active status, but shall not be entitled to annual service increments in accordance with the collective bargaining agreements; and be it further
