WHEREAS, Osteopathic physicians who possess a license to practice medicine as issued by the State Board of Osteopathic Examiners are not presently eligible for appointment to any of the fifteen (15) physician classes listed on the attached amendment; and

WHEREAS, Osteopathic physicians are not eligible for appointment to these classes because they do not possess a license to practice medicine as issued by the State Board of Medical Education and Licensure; and

WHEREAS, The Department of Health has recommended that the qualification requirements of these classes be amended to accept licensure to practice medicine as issued by the State Board of Osteopathic Examiners; therefore, be it

RESOLVED, That in accordance with Section 709(c) of The Administrative Code of 1929, the action of this Board taken July 13, 1956, approving the Compensation Plan for the Commonwealth effective August 1, 1956, be amended to provide for the revisions shown on Amendment No. 114, which is attached hereto and made part of this resolution; and be it further
