WHEREAS, Federal merit system standards, effective October 1, 1965, do not allow the substitution of equivalent experience for formal educational requirements for certain classes in the State's public assistance program; and

WHEREAS, The action of this Board taken on September 21, 1964, Amendment Number 109, Amendment Code 109-62, eliminated the equivalency clause for college graduation from the Caseworker II class; and

WHEREAS, It is deemed desirable to allow the Department of Public Welfare some flexibility in promoting non-college graduates, who are otherwise well-qualified employes, to the Caseworker II class until the Federal merit system standards become effective; therefore, be it

RESOLVED, That the equivalency clauses for formal educational requirements be deleted from the classes listed in the amendment which is attached hereto and made part of this resolution effective October 1, 1965; and be it further

RESOLVED, That the action of this Board taken on September 21, 1964, Amendment Number 109, Amendment Code 109-62, removing the equivalency clause for college graduation from the Caseworker II class be amended to restore the equivalency clause, for promotional purposes only, until September 30, 1965.
