WHEREAS, The Commonwealth entered into a collective bargaining agreement with the Fraternal Order of Police. Conference of Pennsylvania Liquor Control Board Lodges on August 21, 1973, encompassing the non-supervisory Liquor Law Enforcement Unit; and

WHEREAS, A memorandum of understanding between the Commonwealth and the Pennsylvania Liquor Control Board Enforcement Officers III Association is imminent; and

WHEREAS, The above labor agreements stipulate a \$.26 per hour general pay increase effective July 1, 1973; and

WHEREAS, The above mentioned increases are within the Federal Cost of Living Council pay increase guidelines; and

WHEREAS, The contract encompassing the non-supervisory Liquor Law Enforcement Unit provides for the movement of employes in the class Enforcement Officer I to the class Enforcement Officer II; therefore, be it

RESOLVED, That in accordance with Section 709(a) of the Administrative Code of 1929, as amended, the action of this board taken July 13, 1956, approving the Compensation Plan for the Commonwealth effective August 1, 1956, be amended to provide for the revision on Amendment 307 and the revised payschedule which are attached hereto and made part of this resolution; and be it further

RESOLVED, That a general pay increase of \$.26 per hour is hereby authorized for employes covered by the above labor agreements, except as provided below, effective July 1, 1973, without a change in their anniversary dates; and be it further

RESOLVED, That a person on leave without pay or educational leave with pay shall receive the increase upon return to active status; and be it further

RESOLVED, That employes in the class Enforcement Officer I, pay steps C, D, E, F, and G shall receive the \$.26 per hour general pay increase by moving to the class Enforcement Officer II, pay steps A, B, C, D, and E, respectively, effective July 1, 1973, without a change in their anniversary dates; and be it further
