WHEREAS, Job-related required knowledges, skills, and abilities have been identified as a result of this study; and

WHEREAS, The classification specifications for Data Recording Machine Trainee, Data Recording Machine Operator, and Data Recording Supervisor have been revised to reflect these job-related requirements; and

WHEREAS, Classification specifications for Data Recording Supervisor II and Data Recording Supervisor III have been developed to correspond with the levels of supervision which presently exist; therefore, be it

RESOLVED, That the action of this Board taken July 13, 1956, approving the Compensation Plan for the Commonwealth, effective August 1, 1956, be amended to provide for the following additions and revisions, Amendment Codes 323-1 through 323-5 which shall be effective immediately; and be it further

RESOLVED, That notice of proposed rule making pursuant to Sections 201 and 202 of the Commonwealth Documents Law (45 P.S. Sections 1201 and 1202) is omitted in accordance with Section 204 of CDL (45 P.S. Section 1204), as this resolution relates only to Commonwealth organization, management or personnel matters.
