WHEREAS, A memorandum between the Commonwealth and American Federation of State, County and Municipal Employes, AFL-CIO, dated February 10, 1975, encompassing the Law Enforcement (Fish and Game), supervisory employe unit, stipulates general pay increases effective July 1, 1974; therefore be it

RESOLVED, That in accordance with Section 709(a) of The Administrative Code of 1929, as amended, the action of this Board taken July 13, 1956, approving the Compensation Plan for the Commonwealth effective August 1, 1956, be amended to provide for the revised pay schedules and pay range revisions which are attached hereto and made part of this resolution; and be it further

RESOLVED, That the employes shall receive general pay increases effective July 1, 1974 for those periods of employment that they were in an active pay status in accordance with the pay rates on the attached pay schedules, except as provided below, without a change in their anniversary dates; and be it further

RESOLVED, That those employes in the class Game Conservation Officer III currently at theoretical step G shall receive \$7.40 hourly, \$592.00 bi-weekly, and approximately \$15,439 annually effective July 1, 1974, for those periods that they were in an active pay status, without a change in their anniversary dates; and be it further

RESOLVED, That notice of proposed rule making pursuant to Sections 201 and 202 of the Commonwealth Documents Law (45 P.S. Sections 1201 and 1202) is omitted in accordance with Section 204 of CDL (45 P.S. Section 1204), as this resolution relates only to Commonwealth organization, management, or personnel matters.
