WHEREAS, Some of the Commonwealth's adult correction education work has been administered by Luzerne Intermediate Unit 18; and

WHEREAS, Effective July 1, 1978, that work will be administered by Indiana University and the Department of Education under the Governor's jurisdiction; and

WHEREAS, The employes performing the work have been covered by a labor agreement between Luzerne Intermediate Unit 18 Board and Correctional Institution Vocational Education Association which stipulates a schedule of annual pay rates; and

WHEREAS, It is the position of the Commonwealth to maintain the present pay rates; and

WHEREAS, The Commonwealth's Classification and Pay Plans do not contain a class and pay rates to appropriately compensate the above-mentioned employes; therefore, be it

RESOLVED, That in accordance with Section 709(a) of The Administrative Code of 1929, the action of this Board taken July 13, 1956, approving the Classification Plan for the Commonwealth effective August 1, 1956, be amended to provide for the addition shown on Amendment No. 367 which is attached and made part of this resolution; and be it further

RESOLVED, That in accordance with Section 709(a) of The Administrative Code of 1929, the action of this Board taken July 13, 1956, approving the Compensation Plan for the Commonwealth effective August 1, 1956, be amended to provide for the Adult Correction Education Specialist Pay Schedule which is attached and made part of this resolution; and be it further

RESOLVED, That full-time employes shall be paid in accordance with the attached pay schedule; and be it further

RESOLVED, That part-time instructors shall be paid \$8.50 per hour; and be it further

RESOLVED, That part-time supervisors shall be paid \$10.00 per hour; and be it further

RESOLVED, That the Office of Administration shall issue instructions regarding the implementation of the above-mentioned pay schedule and pay rates; and be it further

RESOLVED, That this resolution shall be effective July 1, 1978; and be it further

RESOLVED, That notice of proposed rule making pursuant to Section 201 and 202 of the CDL (45 P.S. Sections 1201 and 1202) is omitted in accordance with Section 204 CDL (45 P.S. Section 1204) as this resolution relates only to Commonwealth organization, management or personnel matters.
